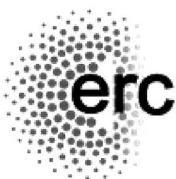

Boaventura de Sousa Santos is Emeritus Professor of Sociology, Director Emeritus of the Centre for Social Studies, University of Coimbra (Portugal), and Distinguished Legal Scholar at the University of Wisconsin-Madison (USA). He has written and published widely on the issues of globalization, the sociology of law and the state, epistemology and social movements. Among his most recent publications are *Cognitive Justice in a Global World: Prudent Knowledges for a Decent Life* (2007); *Epistemologies of the South: Justice against Epistemicide* (2014); *If God Were a Human Rights Activist* (2015); *Épistémologies du Sud* (2016); *Decolonising the University: The Challenge of Deep Cognitive Justice* (2017); *The End of the Cognitive Empire: The Coming of Age of Epistemologies of the South* (2018); *Knowledges Born in the Struggle: Constructing the Epistemologies of the Global South* (2019), edited with Maria Paula Meneses.

Houria Bouteldja is a founding member of le Parti des Indigènes de la République that promotes decolonial politics. She is based in France. She has written numerous theoretical or strategical articles on decolonial feminism, racism, autonomy and political alliances as well as articles on Zionism and state philosemitism. Together with Sadri Khiari she is co-author of *Nous sommes les indigènes de la république* (2012) and *Whites, Jews and Us: Towards a Politics of Revolutionary Love* (2017). She is also part of the Decolonial International Network that aims “to promote the theory and practice of decolonial thinking” throughout the West.

Issa G. Shivji was professor of law at the University of Dar es Salaam (Tanzania) until his retirement in 2006 after 36 years of service and was the first Julius Nyerere Professor of Pan-African Studies (2008–2013) at the same university. He is currently director of the Nyerere Resource Centre at the Tanzania Commission for Science and Technology. Shivji has published over a dozen books and numerous articles including *Class Struggles in Tanzania* (1976), *The Concept of Human Rights in Africa* (1989) and *Let the People Speak: Tanzania Down the Road to Neo-liberalism* (2006). Together with other two colleagues, he is currently finalizing a biography of Nyerere.

João Alexandre Peschanski is the Cáspes Líbero Professor of Political Science and the research supervisor of the dissemination team of the Research, Innovation and Dissemination Center for Neuromathematics at the São Paulo Research Foundation (Brazil). He has a PhD ABD from the University of Wisconsin–Madison Sociology Department, where he has worked on political processes leading to the implementation of free public transit systems in Brazil. He holds a Master's in Political Science from the University of São Paulo. His research interests span a broad agenda associated with emancipatory social sciences and alternative institutional arrangements, more recently in digital communities.

José Manuel Mendes holds a PhD in Sociology from the School of Economics at the University of Coimbra (Portugal), where he is an Associate Professor with Aggregation. He is also a researcher at the Centre for Social Studies, where he works in the fields of risk and social vulnerability, planning, public policies and citizenship. He is a coordinator of the Risk Observatory (OSIRIS) at the Centre for Social Studies and is the editor of *Revista Crítica de Ciências Sociais*.

Juan Carlos Monedero holds a PhD in Political Sciences and is professor of Political Sciences at the Universidad Complutense de Madrid (Spain). In 2018 he received the Social Sciences prize from the Consejo Latinoamericano de Ciencias Sociales (CLACSO). He was part of the movement 15M and is co-founder of the political party Podemos in Spain. Among his most recent publications are *La transición contada a nuestros padres* (2016), *Nuevos Disfraces del Leviatán* (2018), *Curso urgente de política para gente decente* (2013) and *La izquierda que asaltó el algoritmo* (2018).

Mara Bicas is a PhD student in Sociology (specializing in Democracy in the Twenty-First Century) and a junior researcher at the Centre for Social Studies of the University of Coimbra (Portugal). She was a junior researcher for the ALICE research project, coordinated by Boaventura de Sousa Santos and funded by the European Research Council. She graduated in social work and holds a master's degree in Community Psychology about the processes of the democratization of democracy with the Landless Workers Movement (MST), Brazil. Her main fields of research are epistemologies of the South, postcolonial studies, indigenous democracies, plurinational political pluralism and intercultural democracy, especially in the Bolivian context.

Orlando Aragón Andrade holds a graduate degree in Law and a PhD in Anthropological Sciences from the Metropolitan Autonomous University (Mexico). He is a professor at the Universidad Nacional Autónoma de México campus Morelia and also at the Facultad de Derecho y Ciencias Sociales at the Universidad Michoacana de San Nicolás de Hidalgo. His most recent publication is *El derecho en insurrección: Hacia una antropología jurídica militante desde la experiencia de Cherán* (2019).

Rajeev Bhargava is a professor at the Centre for the Study of Developing Societies (CSDS), Delhi and currently director of the centre's Institute of Indian Thought. He was also director of the centre in 2007–2014. He has been a professor at the Centre for Political Studies, Jawaharlal Nehru University, New Delhi (India), and between 2001 and 2005 was head of the Department of Political Science, University of Delhi. He is an Honorary Fellow of Balliol College, Oxford (UK). Bhargava's publications include *Individualism in Social Science* (1992), *What Is Political Theory and Why Do We Need It?* (2010), and *The Promise of India's Secular Democracy* (2010). His edited works are *Secularism and Its Critics* (1998) and *Politics and Ethics of the Indian Constitution* (2008). He is currently working on religious and philosophical pluralism in ancient Indian thought.

Richard Pithouse is an associate professor at the Wits Institute for Social and Economic Research (WiSER) at the University of the Witwatersrand (South Africa), the coordinator of the Johannesburg office of the Tricontinental Institute for Social Research, the editor of *New Frame* and a columnist for the *Mail & Guardian*. His academic interests include political theory, with a particular focus on Frantz Fanon, and popular struggles in South Africa. *Writing the Decline* was published in 2016 and his forthcoming book, tentatively titled *In the Forbidden Quarters*, examines squatter struggles in the city of Durban from the nineteenth century to the present.

Silvia Rivera Cusicanqui is a sociologist and activist with links to the Katarista indigenous movement and the coca growers' movement. In 1983 she joined other indigenous and mestizo intellectuals in founding the Andean Oral History Workshop, an independent group devoted to issues of orality, identity, and popular and indigenous social movements, primarily in the Aymara region. Her most recent publications include "Ch'ixinakax utxiwa: A Reflection on the Practices and Discourses of Decolonization," in *The South Atlantic Quarterly* (2012) and "*Oprimidos pero no vencidos*" *Luchas del campesinado aymara y q'hechwa 1900–1980* (2010). She has produced videos as well as documentary and fiction films. For more than two decades she has been a professor of Sociology at the Universidad Mayor de San Andrés de La Paz (Bolivia). She has also been a visiting professor at Columbia University in New York, the University of Texas at Austin, La Rábida (Huelva), Universidad Nacional de Jujuy (Argentina), and the Universidad Andina Simón Bolívar in Quito.
